DR. CHAVONDA JACOBS-YOUNG

SPEAKER BIO: Dr. Chavonda Jacobs-Young serves as the Under Secretary for Research, Education, and Economics (REE), and as USDA's Chief Scientist. The REE mission area is comprised of more than 8,500 employees with a \$4 billion budget across its five component organizations including the Agricultural Research Service (ARS), Economic Research Service (ERS), National Agricultural Statistics Service (NASS), National Institute of Food and Agriculture (NIFA), and Office of the Chief Scientist (OCS). Together these organizations advance agricultural research, innovation, data, and Extension across a full range of agricultural issues including climate-smart agriculture, nutrition security, equity, and strengthening food supply chains. As Chief Scientist, Dr. Jacobs-Young advises the Secretary of Agriculture and other senior officials on scientific matters and chairs the USDA Science Council, which convenes all parts of USDA's scientific enterprise.



Prior to being appointed by President Biden to serve as the REE Under Secretary, Dr. Jacobs-Young was Administrator for ARS from 2014 to 2022. Prior to that role, she served as ARS Associate Administrator for National Programs, leading the research objectives of the entire Agency. She also led the Office of International Research Programs, which is responsible for ARS' liaison with its international partners. From 2009 to 2012, Dr. Jacobs-Young served as the inaugural OCS Director, where she was responsible for facilitating the coordination of scientific leadership across the Department to ensure that research supported by, and scientific advice provided to, the Department and external stakeholders were held to the highest standards of intellectual rigor and scientific integrity. She has also served as the Acting Director for NIFA and as a senior policy analyst for agriculture in the White House Office of Science and Technology Policy.

Dr. Jacobs-Young is a native of Georgia. She holds M.S. and Ph.D. degrees in Wood and Paper Science and a B.S. degree in Pulp and Paper Science and Technology from North Carolina State University. She is a graduate of American University's Key Executive Leadership in Public Policy Implementation Program, and a proud fellow of both the American Association for the Advancement of Science and the National Academy of Public Administration.



JO ANN LAWRENCE

SPEAKER BIO: As the Deputy District Director for the Louisiana District Office Jo manages the district office staff. She is responsible for providing effective leadership, management and oversight to ensure optimization and deployment of SBA programs and services. She has extensive experience and expertise in providing business development, financial management, contracting, and procurement assistance to small businesses in Louisiana. She is a nationwide expert on the 8(a) Business Development program, HUBZone certification, Woman-owned Small Business certification, Veteran-owned Small Business Certification, 7(j) Management and Technical Assistance, Joint Ventures and Mentor Protégé Programs. Mrs. Lawrence is frequently called upon for training initiatives across the country, and she has worked on several standard operating procedures (SOP) manuals in all areas of small business development. In August 2017, she successfully completed the Excellence in Government Fellows Leadership Program where she improved her leadership skills, increased her knowledge of pathways into the SES Program and increased her knowledge of the SES experience. Jo has more than 49 years of service with the Federal Government, all with SBA.

In 2002, Mrs. Lawrence received the Minority Advocate of the Year Award from the Gulf South Minority Supplier Development Council. In August 2013, Mrs. Lawrence was recognized as a leader for her work in the State of Louisiana by receiving the Louisiana Minority Supplier Development Council's 2013 Leadership Award. In April 2014, she was nominated by the Association for Enterprise Opportunity as a Microbusiness Champion forher support of Prosperity NOLA and microbusinesses in Louisiana. Mrs. Lawrence was recognized by the Association for Enterprise Opportunity during its 2014 National Conference in New Orleans. On July 24, 2014, the Mayor of New Orleans, Senator Mary Landrieu, Congressman Cedric Richmond, Louisiana District Office staff and in excess of 120 current and former Louisiana 8(a) firms recognized Jo Ann Lawrence for 40 years of service to the small businesses in Louisiana. In early April of 2016, she was nominated for the 2016 Small Business Advocacy Award for Federal Government. This national award was presented to her on July 14, 2016,



in Washington, D.C. at the annual ACT-IAC Small Business Growth Symposium. She is a 2017 graduate of the Excellence in Government Fellows Leadership Program. On April 15, 2019, Lawrence received, from Southern University and A & M College, the Business and Community Champion Award for her outstanding leadership and contributions she has made to the small businesses in Louisiana. In July 2019, the SBA Associate Administrator for Field Operations recognized her for 45 years of service. On January 24, 2021, the National Coalition of 100 Black Women New Orleans Chapter, Inc. honored her as the Pandemic Unsung Hero for Economic Development. In April 2021, she was nominated for the Samuel J. Heyman Service to America Medals (Sammies) as part of Public Service Recognition Week 2021. On July 15, 2021, the SBA Deputy Associate Administrator for Field Operations presented her with the Advocate of the Year Award. On June 26, 2022, Lawrence was recognized and honored as a Leader in Entrepreneurship and Economic Empowerment. On May 11, 2023, she was recognized and honored as a Most Valuable Partner by New Orleans Business Alliance.

She is married to Jason Lawrence and is a member of the New Hope Baptist Church where she participates in several ministries.



DEIDRE DECULUS ROBERT

SPEAKER BIO: Robert has over two decades of legal, administrative, and executive management experience and is honored to serve in the Biden-Harris administration as state director of Rural Development for Louisiana. Her legal career began in the Parish Attorney's Office of the City of Baton Rouge-Parish of East Baton Rouge as an assistant city prosecutor. During her 11 years with the city-parish, she advanced to become the first black female section chief. Thereafter, she worked for over six years as an assistant attorney general with the Louisiana Department of Justice, where she served as deputy director of the Public Protection Division, deputy director of the Litigation Division, and special litigation counsel assigned to defend the Louisiana Judiciary. Prior to accepting this presidential appointment, Robert served as the executive counsel for the Louisiana Department of Transportation and Development. Her responsibilities included managing legislative affairs on the federal, state, and local levels and



supervising the innovative procurement, legal and internal audit sections of the agency, as well as the human resources legal matters of the agency. She collaborated with state and local partners to advance infrastructure needs including rail, broadband and bridges throughout the state. Previously, Robert served as general counsel of the Southern University and A&M College System, the only HBCU college system in the country.

SPEAKER BIO: Troy has served the organization for twenty-one years primarily responsible for the organization's financial activities which includes monitoring and reporting on the financial condition of the association. DR. C. PAT BAGLEY

PRESENTATION TITLE: Managing My Cow Herd Through Heat Stress, Lack of Grass, and Lack of Hay

ABSTRACT: This has been a most difficult summer which will lead to an even more difficult winter for livestock producers and their animals. Summer temperatures have been much above normal, and rainfall much below normal over most of the State. High temperatures result in grasses with higher fiber content that are less digestible, and the drought has reduced grass production. Many producers will not be able to produce or purchase enough hay to feed the cow herd through winter. There are many negative factors in livestock production, but some good alternatives. Many producers will find when they wean and sell calves, prices are historically high. Many heavier steers are currently selling for \$2.50/ lb. Beef



cow inventory is at its lowest since the 1950's. So, if forced to sell, at least it is a high cattle market. With the drought, hay supplies are tight and very expensive. But corn and other grains and grain by-products have seen price reductions, making them more attractively priced than usual. Historically, for the price per pound of TDN, corn is one of the cheaper feeds. Many livestock producers will be forced to reduce herd size. My recommendation is to sell all older and poorer-producing cows. They are worth a lot of money at the auction market. Based on hay and other available feed supplies, keep as many heifers as possible. With the US still liquidating its cow herd, females will continue to be higher priced due to a lack of cows, and those calves they produce will be higher priced. But we must survive this winter first.

SPEAKER BIO: Dr. C. Pat Bagley was raised on a dairy, beef, cotton, and timber farm in DeSoto Parish. He obtained a B.S. and M.S. from Louisiana State University and a Ph.D. from Virginia Tech University before his first professional possession at the LSU Rosepine Research Station in Vernon Parish. Dr. Bagley is the Director of the Beef Research Institute at Southern University. Over his career, he has over 500 publications and 7 books or book chapters. His research focus has primarily been on beef cattle and forage management, along with the feeding of by-product feeds to reduce feed costs to livestock.



ASHLYN HARRISON, MA, NCC, LPC

PRESENTATION TITLE: A Rural Response to Farmers Mental Health

ABSTRACT: In the heartlands where crops grow and life thrives, a quiet crisis can unfold.
